



## Blissful Wish Wedding Terms and Conditions

The selected couple will receive a comprehensive donated wedding package for up to 75 guests to include the following items and services at no cost:

- Wedding venue with decorations.
- Food and catering, excluding alcoholic beverages. If the couple wishes to serve alcoholic beverages, they will need to provide alcoholic beverages (beer and wine only) and will be billed by the venue owner for licensed server charges.
- Wedding cake.
- Photographer/videographer.
- Entertainment
- Wedding attire – for couples only.
- Hair and makeup – for couples only
- Wedding Invitations design and stationery. (Postage not included.)

The estimated cost of the donated wedding package is not to exceed \$25,000. Specifications for services will be further defined between the selected couple and participating vendors. The couple may opt to pay vendors directly for additional services, which are not included in the donated wedding package.

*Please communicate with the planning team if you plan to bring other vendors as the venue needs to be informed about any additional arrangements **in writing**. The venue owner may choose not to allow additional vendors if the couple does not communicate with the planning team and the venue.*

The selected couple agrees to the following terms and conditions:

1. Term of this agreement begins upon execution and ends at midnight on the event date.
2. Wedding Party is responsible for any damage done to the premises by guests or independent contractors.
3. Wedding Party must provide a certificate of insurance naming the University of Tennessee as additional insured with limits of \$300,000 per claimant and \$1,000,000 per occurrence for the date of the event.
4. Wedding Party is required to conduct the event in an orderly manner and 'in full compliance with all applicable laws, rules, codes, and regulations.

5. Wedding Party shall indemnify and hold harmless the university, its trustees, officers, employees, and agents from and against any and all third-party claims, demands, suits, legal proceedings, and causes of action, including without limitation any government investigation, enforcement, or other action or proceeding (collectively, "Claims"), arising from, related to, or in connection with this agreement, including Claims alleging, in whole or in part, that the Results were the cause of damages or harm to a person or property.
6. Wedding party will not use the name, trademarks, logos, or other indicia of the university in any publicity or advertising without the prior written approval of the university.
7. This Agreement shall be governed by the laws of the State of Tennessee.

Before completing your application, please verify the following.

- I certify that my partner and I are 21 years or older.
- I certify that we are NOT related to any University of Tennessee employees.
- I understand that once selected as the winning couple, our images, voices, or videos may be used in future educational or promotional materials.
- I am a resident of East Tennessee (Proof of your residency will be requested before signing the contract).
